

Receiving instructions:

After delivery, IMMEDIATELY remove the packaging from the product in a manner that preserves the packaging and maintains the orientation of the product in the packaging; then inspect the product closely to determine whether it sustained damage during transport. If damage is discovered during the inspection, <u>immediately</u> record a complete description of the damage on the bill of lading. If the product is undamaged, discard the packaging.

Hazard Identification--Explanation of SIGNAL WORDS

This manual uses SIGNAL WORDS to indicate the likelihood of personal injuries, as well as the probable seriousness of those injuries, if the product is misused in the ways described. Other signal words call attention to uses of the product likely cause property damage.

The signal words used appear below along with the meaning of each word:

▲ DANGER

Identifies a hazardous situation which, if not avoided, <u>WILL</u> result in DEATH or SERIOUS INJURY. Use of this signal word is limited to the most extreme situations.

AWARNING

Identifies a hazardous situation which, if not avoided, COULD result in DEATH or SERIOUS INJURY.

▲CAUTION

Indicates a hazardous situation which, if not avoided, COULD result in MINOR or MODERATE injury.

NOTICE

Identifies practices likely to result in product/property damage, such as operation that might damage the product.

Each person who assembles, installs, uses, or maintains this product should read the entire manual in advance and fully understand the directions. If after reading the manual you do not understand an instruction, ask your supervisor or employer for clarification, because failure to adhere to the directions in this manual might result in serious personal injury.

SAFETY GUIDELINES

Vestil diligently strives to identify foreseeable hazards associated with the use of its products. However, no manual can address every conceivable risk. The end-user ultimately is responsible for exercising sound judgment at all times.


AWARNING If this product is used improperly or carelessly, the operator and/or bystanders might sustain serious personal injuries or even be killed. ALWAYS use the product properly:


- Failure to read and understand the entire manual before assembling, installing, using or servicing the product <u>constitutes misuse</u>. Read the manual to refresh your understanding of proper use and maintenance procedures.
- DO NOT exceed the maximum rated load.
- Inspect the bicycle rack at least once every 3 months. Remove the rack from service if the inspection reveals structural damage such as: 1) cracked welds; 2) damaged anchor bolts; 3) corrosion, extreme wear, or other condition that affects the ability of the product to support applied weight or itself. DO NOT use the product until it is fully restored to normal condition. ONLY use manufacturer-approved replacement parts.
- DO NOT use the rack UNLESS it is securely anchored to the ground.
- DO NOT remove or obscure any label. All product labels must be readable and undamaged.
- DO NOT modify the bicycle rack in any way. **Unauthorized modifications automatically void the limited** warranty (see p. 4) and might make the rack unsafe to use.

BR-L2-series racks anchor to the ground via 4 bolt holes in each foot pad. Anchor the bicycle rack to the ground through all eight bolt holes with 3/8 in. bolts of appropriate length (dashed arrows).

Inspections and Maintenance:

Inspect the rack at least every couple of months

- Examine the rack for cracked welds, rust, and corrosion.
- Closely inspect the anchor bolts and the ground or wall around the anchor bolts. The rack should be firmly anchored to the ground. If the rack wobbles, tighten the anchor bolts. If the bolts cannot be tightened, re-anchor the rack in another location.

Label placement diagram:

The bicycle rack should bear labels as shown below (in corresponding locations for BR-L2 models).



LIMITED WARRANTY

Vestil Manufacturing Corporation ("Vestil") warrants this product to be free of defects in material and workmanship during the warranty period. Our warranty obligation is to provide a replacement for a defective original part if the part is covered by the warranty, after we receive a proper request from the warrantee (you) for warranty service.

Who may request service?

Only a warrantee may request service. You are a warrantee if you purchased the product from Vestil or from an authorized distributor AND Vestil has been fully paid.

What is an "original part"?

An original part is a part used to make the product as shipped to the warrantee.

What is a "proper request"?

A request for warranty service is proper if Vestil receives: 1) a photocopy of the <u>Customer Invoice</u> that displays the shipping date; AND 2) a <u>written request</u> for warranty service including your name and phone number. Send requests by any of the following methods:

In the written request, list the parts believed to be defective and include the address where replacements should be delivered.

What is covered under the warranty?

After Vestil receives your request for warranty service, an authorized representative will contact you to determine whether your claim is covered by the warranty. Before providing warranty service, Vestil may require you to send the entire product, or just the defective part or parts, to its facility in Angola, IN. The warranty covers defects in the following <u>original</u> <u>dynamic components</u>: motors, hydraulic pumps, electronic controllers, switches and cylinders. It also covers defects in <u>original</u> parts that wear under normal usage conditions ("<u>wearing parts</u>"), such as bearings, hoses, wheels, seals, brushes, and batteries.

How long is the warranty period?

The warranty period for original components is <u>90 days</u>. The warranty period begins on the date when Vestil ships the product to the warrantee. If the product was purchased from an authorized distributor, the period begins when the distributor ships the product. Vestil may extend the warranty period for products shipped from authorized distributors by *up to* 30 days to account for shipping time.

If a defective part is covered by the warranty, what will Vestil do to correct the problem?

Vestil will provide an appropriate replacement for any *covered* part. An authorized representative of Vestil will contact you to discuss your claim.

What is not covered by the warranty?

- 1. Labor;
- Freight;
- 3. Occurrence of any of the following, which automatically voids the warranty:
 - Product misuse;
 - · Negligent operation or repair;
 - Corrosion or use in corrosive conditions;
 - Inadequate or improper maintenance;
 - Damage sustained during shipping;
 - Accidents involving the product;
- <u>Unauthorized modifications</u>: DO NOT modify the product IN ANY WAY without first receiving written authorization from Vestil. Modification(s) might make the product unsafe to use or might cause excessive and/or abnormal wear.

Do any other warranties apply to the product?

Vestil Manufacturing Corp. makes no other express warranties. All implied warranties are disclaimed to the extent allowed by law. Any implied warranty not disclaimed is limited in scope to the terms of this Limited Warranty.
