

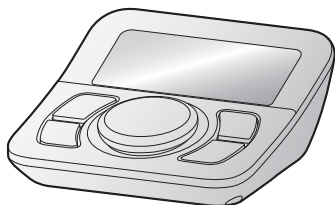

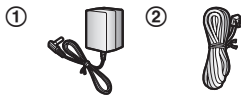



## Important Information

### For your safety

To prevent severe injury and loss of life/property, read this section carefully before using the product to ensure proper and safe operation of your product.

#### WARNING

##### Power connection

- Use only the power source marked on the product.
- Do not overload power outlets and extension cords. This can result in the risk of fire or electric shock.
- Completely insert the AC adaptor/power plug into the power outlet. Failure to do so may cause electric shock and/or excessive heat resulting in a fire.
- Regularly remove any dust, etc. from the AC adaptor/power plug by pulling it from the power outlet, then wiping with a dry cloth. Accumulated dust may cause an insulation defect from moisture, etc. resulting in a fire.
- Unplug the product from power outlets if it emits smoke, an abnormal smell, or makes an unusual noise. These conditions can cause fire or electric shock. Confirm that

- Unplug from power outlets and never touch the inside of the product if its casing has been broken open.

##### Installation

- Unplug the product from power outlets before cleaning. Do not use liquid or aerosol cleaners.
- Do not disassemble the product.
- Do not spill liquids (detergents, cleansers, etc.) onto the telephone line cord plug, or allow it to become wet at all. This may cause a fire. If the telephone line cord plug becomes wet, immediately pull it from the telephone wall jack, and do not use.

## Important Information

### CAUTION

#### Installation and location

- Never install telephone wiring during an electrical storm.
- Never install telephone line jacks in wet locations unless the jack is specifically designed for wet locations.
- Never touch uninsulated telephone wires or terminals unless the telephone line has been disconnected at the network interface.
- Use caution when installing or modifying telephone lines.
- The AC adaptor is used as the main disconnect device. Ensure that the AC outlet is installed near the product and is easily accessible.

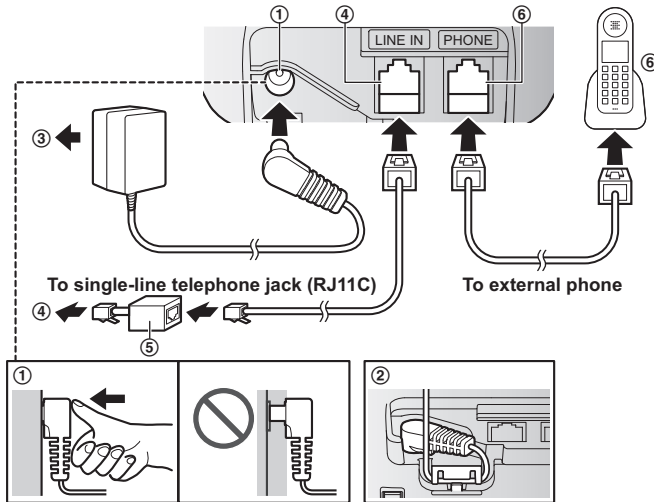
### Setting up

#### Connections

- ① Connect the AC adaptor to the unit by pressing the plug firmly.
- ② Fasten the cord by hooking it.
- ③ Connect the AC adaptor to the power outlet.
- ④ Connect the telephone line cord for your external phone (not supplied) to the unit ("LINE IN" port), then to the single-line telephone jack (RJ11C) until you hear a click.
- ⑤ A DSL/ADSL filter (not supplied) is required if you have a DSL/ADSL service.
- ⑥ Connect the supplied telephone line cord to the unit ("PHONE" port), then connect to your external phone.

#### Note:

- Use only the supplied Panasonic AC adaptor PNLV226.



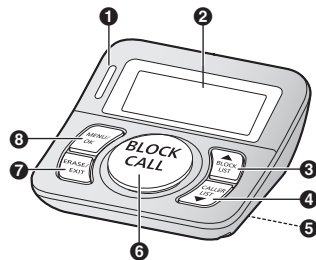


### Note when setting up

#### Note for connections

- The AC adaptor must remain connected at all times. (It is normal for the adaptor to feel warm during use.)
- The AC adaptor should be connected to a vertically oriented or floor-mounted AC outlet. Do not connect the AC adaptor to a horizontally oriented AC outlet that faces the floor, such as an AC outlet installed on a ceiling or under a table, as the weight of the adaptor may cause it to become disconnected.

Red On (5 seconds)	<b>[BLOCK CALL]</b> is pressed when receiving incoming call.

## Language setting

You can select either “**English**” or “**Español**” as the language used for the following features.

- Display
- Talking Caller ID announcement

The default setting is “**English**”.

- 1 **[MENU]**
- 2 **[↕]**: “**Language**” → **[OK]**
- 3 **[↕]**: Select the desired setting  
→ **[OK]** → **[EXIT]**

## Caller ID service

### Important:

- This unit is Caller ID compatible. To use Caller ID features, you must subscribe to a Caller ID service. Contact your phone service provider for details.

## Caller ID features

When an outside call is being received, the caller information is displayed.

Caller information for the last 50 callers is logged in the caller list from the most recent call to the oldest.

- If the unit cannot receive caller information, the following is displayed:
  - “**Out of area**”: The caller dials from an area which does not provide a Caller ID service.
  - “**Private caller**”: The caller requests not to send caller information.
  - “**Long distance**”: The caller makes a long distance call.
- If the unit is connected to a PBX system, caller information may not be properly received. Contact your PBX supplier.

## Talking Caller ID

This feature lets you know who is calling without looking at the display.

To use this feature, you must:

- subscribe to a Caller ID service of your phone service provider.
- turn this feature on.

When caller information is received, the unit announce the caller’s name or phone number received from your phone service provider.

- Name pronunciation may vary. This feature may not pronounce all names correctly.
- Caller ID service has a limit of how many characters can be displayed. If the caller’s name is too long, the unit may not be able to display or announce the entire name.

## Setting Talking Caller ID

The default setting is “on” .

- 1 **[MENU]**
- 2 **[↕]**: “Talking CID” → **[OK]**
- 3 **[↕]**: Select the desired setting. → **[OK]** → **[EXIT]**

## Basic Operation

### Caller list

#### Viewing the caller list

- 1 **[CALLER LIST]**
- 2 Press **[▼]** to search from the most recent call, or **[▲]** to search from the oldest call.
- 3 To exit, press **[EXIT]** 2 times.

#### Erasing selected caller information

- 1 **[CALLER LIST]**
- 2 **[↕]**: Select the desired entry.
- 3 **[ERASE]**
- 4 **[↕]**: “Yes” → **[OK]**
  - To exit, press **[EXIT]** 2 times.

### Call block

The unit can block calls:

- when receiving the call from the phone number in pre-programmed call block list (14,000 items).
- by storing the desired items in the user’s call block list beforehand (up to 2,000 items).

#### Note:

- The numbers stored in the pre-programmed call block list cannot be displayed.
- Depending on your external phone, your phone may ring once while caller information is being received even if you registered the phone number in the call block list.

#### To disconnect the current call and add a phone number to the call block list

You can press the **[BLOCK CALL]** button in the following situations to disconnect the current call and add a phone number to the call block list:

- when an incoming call is being received
- when talking on an outside call using external phone

Once a phone number has been added to the call block list, the unit will block calls from that phone number in the future.

- 1 Press **[BLOCK CALL]** under the situations shown above.
  - The call block number is stored in the call block list, “**CALL BLOCKED**” is displayed and announced, and then the call is disconnected.\*1

## Basic Operation

\*1 If the Talking Caller ID feature is turned off (page 11), “**CALL BLOCKED**” is not announced.

### ■ You can also block calls from your external phone while talking:

Press **#1**

#### Note:

- If the call has no phone number, the call is blocked but it is not stored in the call block list.
- Blocked calls are logged in the caller list.

### Adding call blocked numbers from the caller list

- 1 **[CALLER LIST]**
- 2 **[↕]**: Select the desired entry to be blocked.
- 3 **[BLOCK CALL]**
- 4 **[↕]**: “**Yes**” → **[OK]**
  - To exit, press **[EXIT]** 2 times.

### Setting the block mode

The unit can block calls by setting the following block mode beforehand.

- “**Unknown**” : You can block calls when no phone number is provided, such as private callers or out of area calls.

- “**International**” : You can block the international call.
- “**00 prefix**” : You can block calls whose phone number starts with “00”.

The default setting for each mode is “**Off**”.

- 1 **[MENU]**
- 2 **[↕]**: “**Block mode**” → **[OK]**
- 3 **[↕]**: Select the desired block mode shown above. → **[OK]**
- 4 **[↕]**: Select the desired setting. → **[OK]** → **[EXIT]**

### Viewing/erasing (unblocking) call block numbers

- 1 **[BLOCK LIST]**
- 2 **[↕]**: Select the desired entry.
  - The number of times the entry was blocked is also displayed.
  - After viewing, press **[EXIT]** 2 times to exit.
- 3 **To erase (unblock) a number:**  
**[ERASE]**
- 4 **[↕]**: “**Yes**” → **[OK]**
  - To exit, press **[EXIT]** 2 times.

## Basic Operation

### Erasing all call block numbers

- 1 [BLOCK LIST]
- 2 [MENU] → [↕]: “Erase all” → [OK]
- 3 [↕]: “Yes” → [OK] → [EXIT]

### Allow list

You can allow specific callers to pass through by adding the caller's phone number to the allow list. You can store up to 100 phone numbers (14 digits max.). If the phone number stored in the allow list matches the incoming Caller ID, the ringer indicator flashes green and your external phone rings.

### Adding allowed phone numbers from the caller list

- 1 [CALLER LIST]
- 2 [↕]: Select the desired entry. → [OK]
- 3 [↕]: “Save Allow list” → [OK]

- 4 [↕]: “Yes” → [OK]
  - To exit, press [EXIT] 2 times.

### Adding allowed phone numbers manually

You can also add the phone number in the allow list from your external phone. We recommend you operate while checking the unit's display.

- 1 KX-TGA710/KX-TGA760:  
[MENU]
- 2 [↕]: “Manually save #” → [OK]
- 3 [↕]: “Save Allow #” → [OK]
- 4 Your external phone:
  - When using cordless phone:  
Press [TALK] button.
  - When using corded phone:  
Lift the corded handset.
- 5 [✕][✕][9][1][#] → Enter the phone number (14 digits max.) → [#] → Hang up.

### Viewing/erasing an entry

- 1 [MENU]
- 2 [↕]: “Allow list” → [OK]

- 3 **[↕]**: Select the desired entry.
  - After viewing, press **[EXIT]** 2 times to exit.
- 4 **To erase a number:**  
**[ERASE]**
- 5 **[↕]**: “Yes” → **[OK]**

- 1 **[MENU]**
  - 2 **[↕]**: “Allow list” → **[OK]**  
2 times
  - 3 **[↕]**: “Erase all” → **[OK]**

### Error messages

Display message	Cause/solution
Check LINE IN	<ul style="list-style-type: none"><li>● The telephone line cord has not been connected yet or not connected properly. Check the connections (page 8).</li></ul>
Memory full	<ul style="list-style-type: none"><li>● The call block list memory is full. Erase unwanted entries (page 13).</li><li>● The allow list memory is full. Erase unwanted entries (page 14).</li></ul>
Not accepted	<ul style="list-style-type: none"><li>● Invalid code or character is entered. Try again.</li></ul>
Requires subscription to Caller ID.	<ul style="list-style-type: none"><li>● You must subscribe to a Caller ID service. Once you receive caller information after subscribing to a Caller ID service, this message will not be displayed.</li></ul>

### Troubleshooting

If you still have difficulties after following the instructions in this section, disconnect the AC adaptor, then reconnect the AC adaptor.

#### General use

Problem	Cause/solution
The unit does not work.	<ul style="list-style-type: none"><li>● Check the connections (page 8).</li><li>● Unplug the AC adaptor to reset the unit. Reconnect the adaptor and try again.</li></ul>
The display is in a language I cannot read.	<ul style="list-style-type: none"><li>● Change the display language (page 10).</li></ul>

Problem	Cause/solution
Caller information is not displayed.	<ul style="list-style-type: none"><li>• You must subscribe to Caller ID service. Contact your phone service provider for details.</li><li>• If your unit is connected to any additional telephone equipment such as a Caller ID box or cordless telephone line jack, plug the unit directly into the wall jack.</li><li>• If you use a DSL/ADSL service, we recommend connecting a DSL/ADSL filter between the unit and the telephone line jack. Contact your DSL/ADSL provider for details.</li><li>• The name display service may not be available in some areas. Contact your phone service provider for details.</li></ul>
Caller information is not announced.	<ul style="list-style-type: none"><li>• The Talking Caller ID feature is turned off. Turn it on (page 11).</li></ul>
Caller information is not displayed on your external phone.	<ul style="list-style-type: none"><li>• Turn on the through mode using the following method.<ol style="list-style-type: none"><li><b>1 [MENU]</b></li><li><b>2 [↕]: “Through mode” → [OK]</b></li><li><b>3 [↕]: “On” → [OK] → [EXIT]</b></li></ol>If you turn on the through mode, your external phone rings once even if you registered the phone number in the block list.</li></ul>

### **Liquid damage**

<b>Problem</b>	<b>Cause/solution</b>
Liquid or other form of moisture has entered the unit.	<ul style="list-style-type: none"><li>● Disconnect the AC adaptor and telephone line cord from the unit. After the unit is completely dry, reconnect the AC adaptor and telephone line cord. If the unit does not work properly, contact an authorized service center.</li></ul>

## FCC and other information

This equipment complies with Part 68 of the FCC rules and the requirements adopted by the ACTA. On the bottom of this equipment is a label that contains, among other information, a product identifier in the format US:ACJ-----.

If requested, this number must be provided to the telephone company.

- Registration No.....(found on the bottom of the unit)
- Ringer Equivalence No. (REN),.....0.1A

A plug and jack used to connect this equipment to the premises wiring and telephone network must comply with the applicable FCC Part 68 rules and requirements adopted by the ACTA. A compliant telephone cord and modular plug is provided with the product. It is designed to be connected to a compatible modular jack that is also compliant.

The REN is used to determine the number of devices that may be connected to a telephone line. Excessive RENs on a telephone line may result in the devices not ringing in response to an incoming call. In most but not all areas, the sum of RENs should not exceed five (5.0). To be certain of the number of devices that may be connected to a line, as determined by the total RENs, contact the local telephone company. For products approved after July 23, 2001, the REN for the product is part of the product identifier that has the format

US:AAAEQ##TXXXX. The digits represented by ## are the REN without a decimal point (e.g., 03 is a REN of 0.3).

If this equipment causes harm to the telephone network, the telephone company will notify you in advance that temporary discontinuance of service may be required. But if advance notice isn't practical, the telephone company will notify the customer as soon as possible. Also, you will be advised of your right to file a complaint with the FCC if you believe it is necessary.

The telephone company may make changes in its facilities, equipment, operations or procedures that could affect the operation of the equipment. If this happens the telephone company will provide advance notice in order for you to make necessary modifications to maintain uninterrupted service.

## Panasonic Products Limited Warranty

### Limited Warranty Coverage (For USA Only)

If your product does not work properly because of a defect in materials or workmanship, Panasonic Corporation of North America (referred to as "the warrantor") will, for the length of the period indicated on the chart below, which starts with the date of original purchase ("warranty period"), at its option either (a) repair your product with new or refurbished parts, (b) replace it with a new or a refurbished equivalent value product, or (c) refund your purchase price. The decision to repair, replace or refund will be made by the warrantor.

During the "Labor" warranty period there will be no charge for labor. During the "Parts" warranty period, there will be no charge for parts. This warranty only applies to products purchased and serviced in the United States. This warranty is extended only to the original purchaser of a new product which was not sold "as is".

**IF REPAIR IS NEEDED DURING THE WARRANTY PERIOD, THE PURCHASER WILL BE REQUIRED TO FURNISH A SALES RECEIPT/PROOF OF PURCHASE INDICATING DATE OF PURCHASE, AMOUNT PAID AND PLACE OF PURCHASE. CUSTOMER WILL BE CHARGED FOR THE REPAIR OF ANY UNIT RECEIVED WITHOUT SUCH PROOF OF PURCHASE.**
