- Consumable items are defined as expendable parts or accessories expected to become inoperable within a reasonable amount of use and are covered by a 90 day limited warranty against manufacturer's defects.

## What is Covered

This warranty covers any defects in workmanship or materials subject to the limitations stated below. This warranty does not cover failures due directly or indirectly to misuse, abuse, negligence or accidents, normal wear-and-tear, improper repair, alterations or lack of maintenance.

If we determine you are covered by the Unbreakable® Handle Guarantee, we will send you \$1,000. If our inspection discloses a defect but you are not covered by the B.A.S.H® \$1,000 Guarantee, we will repair or replace the product, or refund the purchase price, at our option, in accordance with our standard limited warranty above
