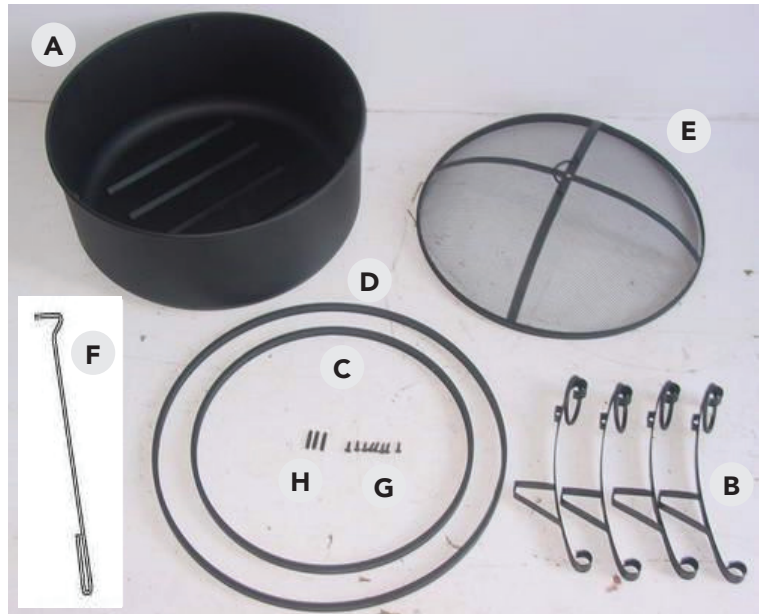

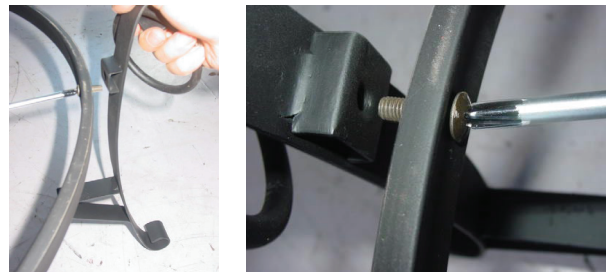

Carefully unpack all parts. Inspect for missing or damage parts.

ASSEMBLY

STEP 1:

Align hole in the Large Ring with hole in the Stand Leg, insert Bolt (M6) through the holes and securely fasten bolt with a screwdriver. Do not over-tighten bolts.



STEP 2:

Follow Step 1 above to assemble the rest of the Stand Legs.

ASSEMBLY

STEP 3:

Align the holes of the Small Ring with the holes of Stand Leg, insert Bolts (M6) through each hole and securely fasten bolt with a screwdriver. Do not over-tighten bolts.



STEP 4:

Follow Step 3 above to assemble the rest of the Stand Legs.



STEP 5:

Insert Bolts (M8) in the top wall of Fire Bowl and tighten. Place Fire Bowl into the holder.



STEP 6:

Place Spark Screen on the Fire Bowl.
