




- A Power LED Illuminates blue to indicate that the unit is connected to a power source using the external power supply and receiving power

USB Charging

To charge your USB devices, simply connect the included external power supply between the U280-010-ST and a power source, then plug your devices into the available ports. Each port provides a maximum of 5V, 2.4A of power. Up to 5V, 2A of power can be simultaneously provided to each port.


Note: In the event that more power is being pulled than the U280-010-ST can provide, the unit's over-current protection will cause the USB ports to cycle on and off, preventing any of the connected devices from being charged. If this occurs, reduce the load by removing devices until the total load comes within the supported range.
