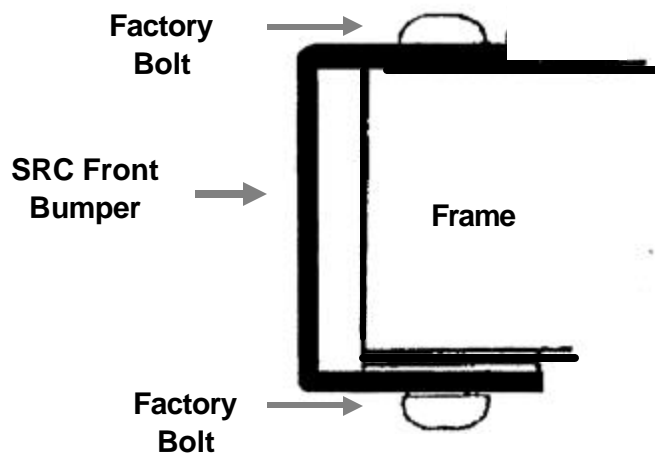
### INSTALLATION INSTRUCTIONS

2. Install Rock Crusher Front Bumper onto vehicle using the factory hardware removed in step one.
