Ultra-Tow's Aluminum Arched Folding Ramp set is made from high quality aluminum and includes adjustable attachment straps. The ramps are rust and corrosion resistant. The arched bi-fold design prevents bottoming out of equipment with low ground clearance. The ramps fold for easy storage.

Assembly Instructions

Be sure you are loading on a hard, level, and stable surface. The vehicle you are loading into should be parked with the emergency/parking brake in “park” and the engine off. Unfold and place the lips of the ramps against the back of the vehicle. Secure the ramps to the vehicle using safety straps.

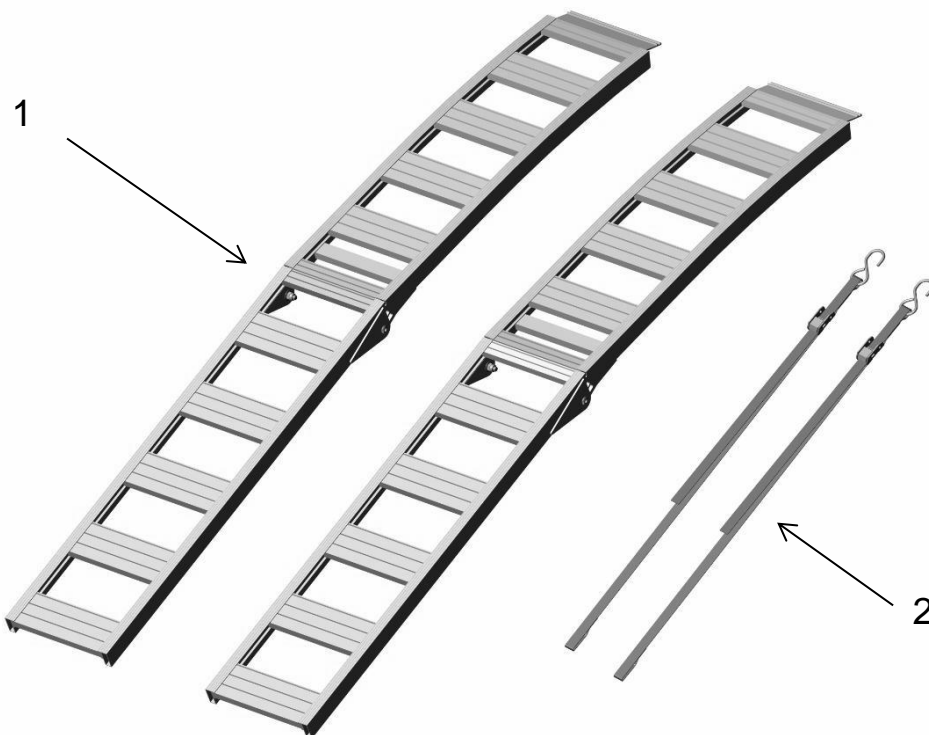
Maintenance

Maintain the ramps with care. Inspect them periodically, and if damaged, have them repaired by an authorized technician.

For your safety, maintenance should be performed regularly by a qualified technician.

Clean the ramps after each use. Make sure any dirt, oil, grease, or debris is not present on the ramp.

The foregoing warranty is valid only if the installation and use of the product is strictly in accordance with product instructions. There are no other warranties, express or implied, including the warranty of merchantability or fitness for a particular purpose. If the product does not comply with this limited warranty, Your sole and exclusive remedy is that We will, at our sole option and within a commercially reasonable time, either replace the product or product component without charge to You or refund the purchase price (less shipping). This limited warranty is not transferable.

Limitations on the Warranty

This limited warranty does not cover: (a) normal wear and tear; (b) damage through abuse, neglect, misuse, or as a result of any accident or in any other manner; (c) damage from misapplication, overloading, or improper installation; (d) improper maintenance and repair; and (e) product alteration in any manner by anyone other than Us, with the sole exception of alterations made pursuant to product instructions and in a workmanlike manner.
